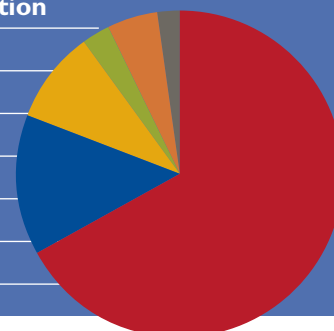

Georgia State Law offers a blended traditional and innovative curriculum designed to meet the needs of our students and reflect the growing reach of technology.

We build on the foundational areas of the law with flexible options and elective opportunities that cover virtually all aspects of public and private law.

In the first year, you will cover civil procedure, contracts, criminal law, property law, torts and our newly reimagined Lawyering: Foundations course, which satisfies the legal writing and research requirement through frequent, simulated real world writing projects such as memos and briefs.

In your second and third years, you'll choose from a wide array of elective courses that give a glimpse into the day-to-day of a working lawyer: counseling, negotiation, legal drafting and alternative dispute resolution, among many others. Varied theory and special interest courses also are available, such as law and religion, arts and entertainment law, or human subjects research, in addition to required courses like Lawyering: Advocacy (a hands-on litigation course), Constitutional Law and Professional Responsibility.

Our flexible program allows you to choose the pace that suits your needs. The accelerated program will allow you to complete the program in just two and a half years, while the part-time program allows additional time for working students to complete their studies.

PRACTICE: Experiential Learning at Georgia State Law

Bankruptcy Assistance and Practice Program

The Bankruptcy Assistance and Practice Program allows second- and third-year students to work with Atlanta Legal Aid Society and low-income Georgians facing debt crisis, foreclosure and bankruptcy.

Capital Defender Clinic

The Office of Georgia Capital Defenders accepts second- and third-year students to assist attorneys in all aspects of preparing indigent clients' death penalty cases for trial in each phase of the case.

Fundamentals of Law Practice

Learn practical skills and ethical decision-making through simulating the work of a small, general practice law firm in Fundamentals of Law Practice. Course work includes simulation exercises and actual client representation in domestic violence cases.

HeLP Legal Services Clinic

The HeLP Legal Services Clinic represents the low-income families of children receiving health care services through Children's Healthcare of Atlanta. Students work with clinical faculty and a variety of partners—including medical schools, social workers and public health educators—to hone skills in client interviewing and counseling, case management and other advanced aspects of health related cases.

Health Legislation and Advocacy

This two-semester clinic examines the process by which legislation is enacted into state law—including drafting, legislative organization and procedure, ethics and lobbying, and the appropriations process. Students work with a community partner organization or agency on upcoming proposed health-related legislation in the Georgia General Assembly.

International Programs

Compare alternate legal systems and societal challenges around the world. Study abroad options include the Summer Academy in International Commercial Arbitration in central Europe and the Summer Legal Study in Rio de Janeiro.

Investor Advocacy Clinic

The Investor Advocacy Clinic trains students in arbitration, negotiation and mediation as they work with investors who have suffered losses resulting from broker misconduct and cannot secure private legal representation because of the size of their claim. Students also provide smart investment education to the public.

Philip C. Cook Low-Income Taxpayer Clinic

Students provide legal representation to low-income individuals during the post-audit stage of their disputes with the Internal Revenue Service. The tax clinic provides professional skills and substantive training on filing status, credits and exemptions, immigration status and collection issues.

Urban Fellows

Urban Fellows is an interdisciplinary initiative of the Center for the Comparative Study of Metropolitan Growth, which connects top graduate students from Georgia State University and Georgia Institute of Technology's School of City and Regional Planning to scholars and leading professionals to study and discuss issues related to urban growth.

INNOVATIVE PRACTICE-BASED CURRICULUM

During your first year, Georgia State Law introduces you to the world of practice through our new course, Lawyering: Foundations, which focuses attention on writing, problem solving and advocacy skills. You will learn what lawyering is all about with more assignments, smaller sections and more feedback.

In your second year, you'll build upon your writing and advocacy skills in Lawyering: Advocacy – a hands-on litigation course. Students develop the skills needed in representing a client from initial interview to discovery and pre-trial motions, and throughout the trial process.





As you prepare to practice law, you'll find a wide range of purposeful and practical learning experiences at Georgia State. You can choose from externships and clinical courses to apply classroom theories and skills in the world of practice.

Externships

The Externship Program places law students with more than 70 government agencies, nonprofit organizations and judges in Atlanta in virtually every area of the law. You will receive academic credit for work done under the supervision of practicing attorneys and judges at pre-approved externship sites.

Career Services

In today's market, you must be a competitive candidate with an extensive professional network. The Office of Career Services (CSO) is of great value to both students and alumni providing instruction, tools and resources for them to become and remain competitive. Visiting speakers and guest career counselors supplement the office's regular offerings, which include resume and cover letter workshops, networking events, on-campus interviews and general career guidance.

Year-round employment opportunity listings including part-time, summer, temporary and full-time positions are posted online and promoted through regular e-mail communications to students and alumni.


S.H.A.R.P.

Financial Aid

Major sources of funding that may be available include: scholarships, tuition waivers, federal loans and private educational loans. Scholarships and tuition waivers are administered within the College of Law.

Scholarships, Awards and Tuition Waivers

All students, once accepted for admission to the College of Law, are considered for appropriate scholarships and tuition waivers. Tuition waivers are based on academic achievement and include student employment such as graduate research and teaching assistantships. Fees

Applying for Federal Financial Aid

The first step is to complete the Free Application for Federal Student Aid. This form is available beginning the first week of January each year and should be completed online as early as possible at fafsa.ed.gov, and no later than **Tuesday, April 1**.

- Submit FAFSA

ACADEMIC ENRICHMENT PROGRAM

The Academic Enrichment Program provides assistance in selected required classes to help students avoid or overcome academic difficulty. 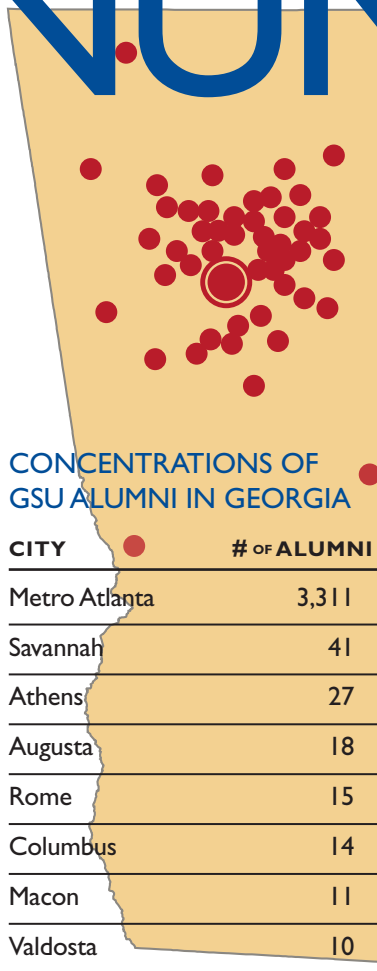

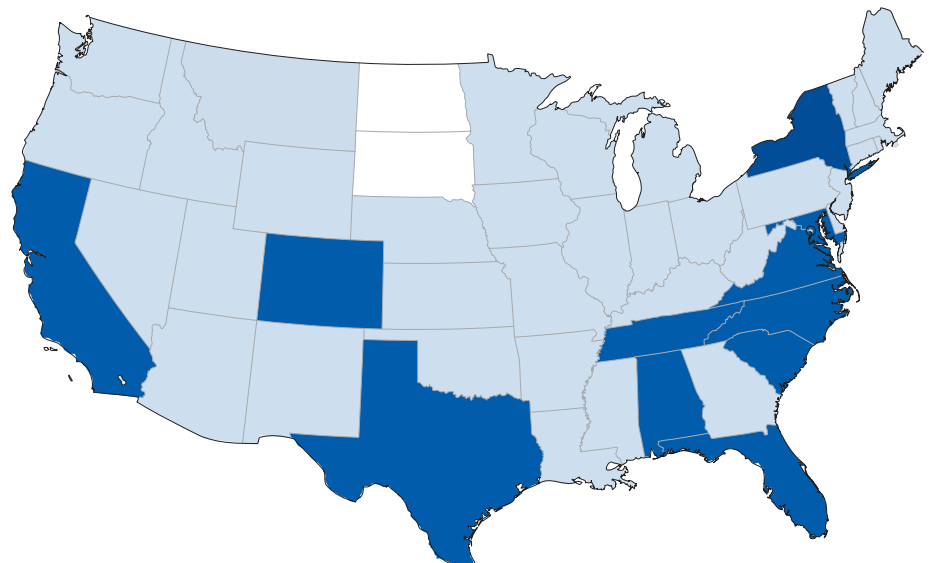
