





Georgia State Law offers an innovative curriculum that blends skills with legal theory to meet the needs of our students and reflect the growing reach of technology. We build on the foundational areas of the law with flexible programs and electives that cover virtually all aspects of public and private law.

In the first year, you will take Civil Procedure, Contracts, Criminal Law, Property Law, Torts and our Lawyering: Foundations course. Through these courses, you will satisfy legal writing and research requirements and gain a foundation for future legal study.

In your second and third years, you will choose from a wide array of elective courses that allow you to tailor your education to your interests. Whether your future endeavors center on Criminal, Civil, Public or Private Law or a combination, you will find a wide variety of classes to fit your curiosities.

Hands-On Learning at Georgia State Law

Bankruptcy Assistance & Practice

The Bankruptcy Assistance and Practice Program allows second- and third-year students to work with Atlanta Legal Aid Society and low-income Georgians facing debt crisis, foreclosure and bankruptcy.

The Pro Se Assistance Project (P.A.P.)

Volunteer bankruptcy attorneys and students provide free legal guidance through 20-minute consultations to individuals representing themselves in proceedings.

Capital Defender Clinic

The Office of Georgia Capital Defenders accepts second- and third-year students to assist attorneys in all aspects of preparing indigent clients' death penalty cases for trial in each phase of the case.

Fundamentals of Law Practice

Learn practice skills and ethical decision-making through simulating the work of a small, general practice law firm in Fundamentals of Law Practice. Course work includes simulation exercises and actual client representation in domestic violence cases.

Health Legislation and Advocacy

This two-semester clinic examines the process by which legislation is enacted into state law—including drafting, legislative organization and procedure, ethics and lobbying, and the appropriations process. Students work with a community partner organization or agency on upcoming proposed health-related legislation in the Georgia General Assembly.

HeLP Legal Services Clinic

The HeLP Legal Services Clinic represents the low-income families of children receiving health care services through Children's Healthcare of Atlanta. Students work with clinical faculty and a variety of partners—including medical schools, social workers and public health educators—to hone skills in client interviewing and counseling, case management and other advanced aspects of health related cases.

INNOVATIVE PRACTICE-BASED CURRICULUM

Lawyering: Foundations focuses attention on writing, problem-solving and advocacy skills. In your second year, you'll build on these skills in *Lawyering: Advocacy*, a hands-on litigation course that develops the skills needed in representing a client from the initial interview to discovery and pre-trial motions, and throughout the trial process.

Investor Advocacy Clinic

The Investor Advocacy Clinic trains students in arbitration, negotiation and mediation as they work with investors who have suffered losses resulting from broker misconduct and cannot secure private legal representation because of the size of their claim. Students also provide smart investment education to the public.

Landlord – Tenant Mediation Clinic

Students mediate landlord/tenant disputes and other disputes, including cases handled in the State and Magistrate courts; particularly small claim civil issues such as disputes between neighbors, consumers and businesses and creditors and debtors.

Law Volunteer Clinic for Veterans

The Law Volunteer Clinic for Veterans provides free legal assistance to student veterans at Georgia State. Volunteer attorneys assist veterans with most legal issues including veterans benefits, divorce, wills, landlord/tenant and discharge issues.

Olmstead Disability Rights Clinic

The Olmstead Disability Rights Clinic is a partnership with Atlanta Legal Aid Society's Disability Integration Project. Inspired by advocacy based on the Supreme Court case *Olmstead v. L.C.*, the clinic and participating students help clients obtain the assistance they need to live at home instead of in an institution.

Philip C. Cook Low-Income Taxpayer Clinic

Students provide legal representation to low-income individuals during the post-audit stage of their disputes with the Internal Revenue Service. The tax clinic provides professional skills and substantive training on filing status, credits and exemptions, immigration status and collection issues.

Transactional Assistance & Practice Program

The Transactional Assistance and Practice Program allows students to represent nonprofit organizations referred by the Pro Bono Partnership of Atlanta in a variety of transactional and corporate legal problems.

Urban Fellows

Urban Fellows is an interdisciplinary initiative of the Center for the Comparative Study of Metropolitan Growth, connecting graduate students from Georgia State and Georgia Institute of Technology's School of City and Regional Planning to scholars and leading professionals to study and discuss issues related to urban growth.





THE LAW REVIEW




National Institute for Teaching Ethics and Professionalism

Financial Aid

Major sources of funding that may be available include: scholarships, tuition waivers, federal loans and private educational loans.

Scholarships and tuition waivers are merit based and administered within the College of Law.

Scholarships, Awards and Tuition Waivers

All students, once accepted for admission to the College of Law, are considered for appropriate scholarships and tuition waivers. Tuition waivers are based on academic achievement and include student employment such as graduate research and teaching assistantships. Fees

In addition to tuition, Georgia State charges student fees each semester that are used to implement a variety of programs. As of Jan. 1, these fees total \$1,121 per semester. They may change in the summer.

Applying for Federal Financial Aid

The first step is to complete the Free Application for Federal Student Aid. This form is available beginning the first week of January each year and should be completed online as early as possible at fafsa.ed.gov. The priority deadline is Saturday, April 1.

Note: Financial aid is disbursed after the first week of classes. Excess aid is refunded to a student's account two weeks after class begins. Also, tuition and fees are subject to change.

THE MINDFULNESS PROGRAM provides weekly sessions where law students can come and learn relaxation and stress-relief techniques, helping them address anxiety and learn how to ignore distractions and improve their focus and attention. Weekly yoga classes go hand in hand with the program, by providing benefits like lowering stress, anxiety and impatience while increasing focus and body awareness.

ACADEMIC SUCCESS PROGRAM

The Academic Success Program provides assistance in selected required classes to help students avoid or overcome academic difficulty. Faculty members lead skill-building workshops, while student tutors follow up with small group review. The program is designed to follow first-year coursework, so students learn study and research skills in context.

ADMISSIONS DISCLOSURE

The College of Law admitted you based upon your certification that your application materials are complete and accurate.

If you have omitted anything or any information changes, you must amend your application immediately. This obligation shall continue until you graduate from the College of Law. Misrepresentations may result in the invalidation of your application, revocation of admission, discipline under the College of Law Honor Code, report to the LSAC or bar authorities and/or other actions.

Pay close attention to Questions 3 and 4 on the Character and Fitness section of your application, and the Criminal Certification following Question 4.

Note: All moving violations must be disclosed; only parking tickets are exempt.

If you are uncertain where you will practice law, you may wish to review the Standard NCBE Character and Fitness Application, titled Request for Preparation of a Character Report, of the National Conference of Bar Examiners, which is used by a number of jurisdictions' bar admission authorities. Addresses for all relevant agencies are available at ncbe.org.

Complete information about Georgia's character and fitness rules, as well as bar exam and admission procedures, may be found at gabaradmissions.org. Students applying for admission in states other than Georgia are encouraged to review the specific admissions requirements of those states.
